Guidance for completing the application form for tax deduction card/advance tax for foreign citizens

1. Personal details and contact information

Enter your full name in the order shown on the form. You must state your citizenship and country of birth (optional). Enter an e-mail address and telephone number (including the country/dialling code) we can contact you via

2. Identity

Enter your identity number and insert a tick to indicate the type of number concerned. If you have lived/worked in Norway, you will have been given a Norwegian D number or national ID number. If you have been issued with a residence permit in Norway, you will have been given a DUF number, which will be shown on your residence permit.

Identity document

- Identity document type is the type of document that is presented, e.g. a passport, national identity card or driving licence.
- Identity document number is the number of the document, e.g. passport number or driving licence number.
- Name of issuer is the name of the agency that issued the document, e.g. Oslo Police District, the Norwegian Public Roads Administration or the Swedish Tax Agency.
- The country of issue is the country in which the document was issued.
- Valid from is the date from which the document is valid.
- Valid to is the date until which the document is valid.

Any foreign personal identification

- All information entered under personal identification must be based on the information given in the attached identity document.
- Personal identification number type can be TIN, SSN or a foreign PID. TIN stands for Taxpayer Identification Number and is a tax number, SSN stands for Social Security Number and is a social security number, and PIN stands for Personal Identifier and is a foreign national ID number or other identification from the person's home country.
- Personal identification number is the actual number if the type is TIN, SSN or foreign PID. These are mainly numbers, but they may also consist of letters.

4. Postal address in Norway

We will send confirmation of your D number/national ID number and tax deduction notice to the specified postal address. Any c/o address will be for the person you are staying with. If your address changes, it is important that you inform the Norwegian Tax

Administration of your new address. You can report a change of address using an electronic form via www.skatteetaten.no (log-in via PIN codes). If you only wish to change your postal address and you are not actually moving, you can submit the form "Notification of a new/amended postal address"

5. Residential address in Norway (Only complete if this is different from your postal address)

If you plan to commute to Norway on a daily or weekly basis, go straight to box 6. 6. Address in home country/Address after your stay in Norway

State your address in your home country or another address you are planning to travel to after your stay in Norway is over. If your address changes, it is important that you inform the Norwegian Tax Administration of your new address. See point 4. We will then be able to send you post, e.g. a tax return for the following year. If you do not know where you are going, enter your postal address in your home country.

7. Employer you are employed by/receive salary from

Enter the name and organisation number of the employer you are working for or have received a job offer from. If you work on the Norwegian continental shelf, insert a tick for this.

8. Salary and remunerations from employer

State your expected income and allowances in NOK from your employer this year. If you receive board fees, insert a tick for this if applicable. You must also state how much of your salary concerns board fees. If you have any expenses for subsistence, lodging and/or visits to your home country partly or fully covered by your employer, insert a tick for this. Based on the information you have given in the application, the Norwegian Tax Administration will then decide whether the tax deduction card should include the standard deduction.

9. Own enterprise

If you run your own enterprise, you must state the organisation number and expected business income (annual income). Business income must include profits from sole proprietorships and businesses assessed as a partnership.

10. Date and signature

Sign the form to confirm that the information you have given is correct.
